Next Generation Dairy Farmer

Dijkshoorn is 25 years old and aims to take over the farm of her parents or parents-in-law in the future. She is active as the chair of the youth council of FrieslandCampina and works as a teacher/researcher at Van Hall Larenstein, a vocational university in the Netherlands.



Dr. Qu Dongyu

Director-General, FAO

Dr. Qu took office as Director-General of the United Nations Food and Agriculture Organization on August 1, 2019. He previously served as China's Vice Minister of Agriculture and Rural Affairs, where one of his achievements was to promote inclusive and innovative development and to ensure information and communication technologies were available in rural areas so that more than 400 million farmers could use their smartphones as a new farming tool. Dr. Qu's career includes working in central and local government, at research institutes and as a human resources leader at the China Three Gorges Project Development Corporation (the largest green energy company in the world). He has spent his life working on how to ensure the world is fed. His vision is founded on the belief that freedom from hunger is a basic human right, and that in the 21st century we have the capability to eradicate chronic food insecurity.



Geoff Dooley

Head of Sustainability Services, Antaris Consulting

Dooley has advised several farming organizations on integrating environmental regulations with policy and strategy, including the Irish Farmers Association and the Irish Creamery Milk Suppliers Association. He also recently facilitated the development of Ireland's Environmental Protection Agency's Climate Impacts and Adaptation Strategy (2022 – 27). Previously, Dooley was awarded a Nuffield Farming Scholarship and served as Chair of Nuffield Ireland and Director at Nuffield International.



Gina Gutierrez
Next Generation Dairy Farmer

Gutierrez is a fifth-generation dairy farmer whose farm is located in the highlands of central Mexico. She is on the sustainability and risk management committee of her dairy cooperative, Alpura, serves as the community outreach advocate for Global Farmer Network and is a columnist for three magazines in Mexico. Gutierrez is also a dairy ambassador for GDP and has spoken on behalf of the dairy sector at various intergovernmental fora.



Krysta Harden
President and CEO, U.S. Dairy Export Council

Harden has been President and CEO of the U.S. Dairy Export Council since February 2021, where she directs a staff of dairy trade specialists, trade policy professionals, a global marketing team and a strategy and insights team. She also oversees 10 international offices working to facilitate dairy product and ingredient application knowledge, identify market opportunities, monitor regulatory activity and work toward improving the business climate for U.S. dairy. Harden previously worked for Dairy Management Inc. to define the vision, strategy and plan forward for U.S. dairy's environmental commitment. Those goals were officially announced in the fall of 2020, including a plan to reach net zero emissions by the year 2050. She has also served as Senior Vice President of External Affairs and Chief Sustainability Officer for Corteva Agriscience, Deputy Secretary at the U.S. Department of Agriculture and CEO of the National Association of Conservation Districts.



Dr. Jeremy Hill
**Chief Science and Technology Officer,
 Fonterra Co-operative Group
 Professor of Sustainable Nutrition, Riddet
 Institute, Massey University**

Professor Hill has worked for Fonterra for more than 30 years, the last 15 as Chief Science and Technology Officer. He is currently Chair of the Pastoral Greenhouse Gas Research Consortium and sits on the Board of the NZ Agricultural Greenhouse Gas Research Centre. Professor Hill established the Sustainable Nutrition Initiative at the Riddet Institute in 2018, where he holds an Adjunct Professorship in Sustainable Nutrition. He served as President and Chair of the Board of the International Dairy Federation from 2012-2016. Professor Hill was bestowed by HRH Queen Elizabeth II as a Member of the New Zealand Order of Merit for services to science and industry in the 2020 Queen's Birthday Honours.

 Royal FrieslandCampina**

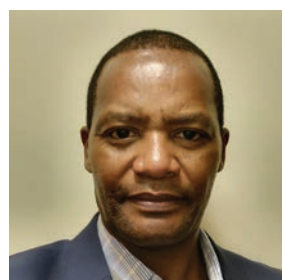

John Kerry

U.S. Special Presidential Envoy for Climate

Kerry has held the role of U.S. Special Presidential Envoy for Climate since January 20, 2021. He previously served as the 68th U.S. Secretary of State from 2013 to 2017 under President Barack Obama and signed the Paris Climate Agreement on behalf of the U.S. in 2016. Kerry is a former U.S. Senator and served in the U.S. Navy, completing two combat tours of Vietnam for which he received a Silver Star, a Bronze Star with Combat V and three Purple Hearts.



Bernard Nyakundi Kimoro

Head, Climate Change and Livestock Sustainability, State Department for Livestock, Ministry of Agriculture, Livestock, Fisheries and Cooperatives, Republic of Kenya

Kimoro leads the climate change adaptation and mitigation policies and measures for the livestock sub-sector in Kenya. He previously worked in rural development as a Dairy Production Specialist in the Government of Kenya/International Fund for Agricultural Development project where he was the focal point on climate change adaptation actions in dairy production. As a development agent, Kimoro has extensive skills and knowledge in the areas of: livestock climate change policy; climate change negotiations on agriculture and livestock; livestock GHG modeling; climate change, food security and livelihoods nexus; and livestock environmental assessments, sustainability and mitigation.



Mary Ledman

Global Dairy Strategist, Rabobank Group

Ledman joined RaboResearch as Global Sector Strategist – Dairy in January 2018. She currently leads a team of analysts around the globe and is tasked with analyzing developments in regional and global dairy markets, developing the bank's medium-term dairy forecasts and advising the bank on its engagement with the dairy industry. Ledman is a thought leader who has extensive knowledge of international dairy markets and policy with more than 30 years experience with the U.S. Department of Agriculture, Kraft Foods, Stella Foods and the publisher of the Daily Dairy Report.

At GRA, he represents its 66 member countries in all international fora and facilitates mitigation research between its members and partner organizations. From 2013 to 2016, he was New Zealand's Ambassador to Argentina, Paraguay, and Uruguay. Montgomery has considerable experience working within the United Nations' climate change process, representing New Zealand in agriculture, land use and forestry negotiations between 2006 and 2012. From 2010-2012, He also spearheaded New Zealand's international research cooperation on agricultural greenhouse gases.

for Agricultural Development

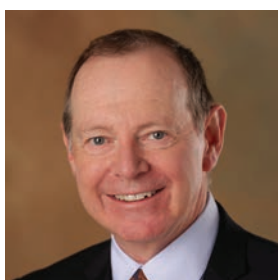

Before joining GDP, Moore spent 10 years with Fonterra Co-operative Group in a variety of roles, including Managing Director, Oceania; Director, Business Development; and Director, Ingredients Marketing. Prior to his involvement in the dairy sector, he spent 10 years as Chief Executive of New Zealand's largest independent business and information management consulting firm.



Hanne Søndergaard

Executive Vice President and Chief Agriculture and Sustainability Officer, Arla Foods

Søndergaard is EVP for Agriculture, Sustainability and Communications and a member of the Executive Management Group at Arla Foods, a farmer-owned dairy cooperative. With a clear commitment to contribute to a stronger planet and stronger people, she is leading Arla's full scope transition to sustainable dairy. This includes dairy farming, packaging, food waste, carbon net zero production, health and nutrition, international dairy development and human rights. Søndergaard is currently Deputy Chair of GDP's Board.



Dr. Samuel Thevasagayam

Deputy Director, Livestock Agriculture Development, Bill & Melinda Gates Foundation

Dr. Thevasagayam leads the Livestock portfolio within the Agriculture Development Program at the Bill & Melinda Gates Foundation. He oversees implementation of the foundation's strategy in animal health, animal production and animal systems. Prior to joining the foundation in 2012, Dr. Thevasagayam spent most of his career within the pharmaceutical industry and is responsible for the development and registration of several drugs and vaccines (human and animals).



Vikki Tam

Tam joined Bain & Company in 1998 and is currently head of the firm's Global Social Impact Practice, where she leads multi-year, global, pro bono partnerships in economic development with innovative and high-impact nonprofits.
